Dear Ms. Davis,

In response to your letter dated April 22, 2011, attached please find the amended pages to the 2010 July Quarterly report.

The individuals who had incorrect aggregate year-to-date figures have been corrected. This problem was due to duplicate records in our database and we have merged all applicable records to resolve this issue. In doing this, there were several errors that were found and have been corrected:

1. The contribution from Tom G Murdough, Jr on 6/30/10 was incorrectly input under "Tom" instead of "Joy Murdough." This has been corrected and is reported as such on the amendment.
2. Walter M. Rosebrough, Jr. – This individual had two separate records in our database. At the time the contribution was received, these records were viewed as two separate individuals. Once we found out and verified that these were, in fact, the same person, we immediately issued a refund for the amount that was over the individual contribution limit.
3. Victor Scaravilli - This individual had two separate records in our database. At the time the contribution was received, these records were viewed as two separate individuals. Once we found out and verified that these were, in fact, the same person, we immediately issued a refund for the amount that was over the individual contribution limit.

Additionally, regarding Occidental Petroleum Corp. PAC – The ECTD is correct at \$6,000. We issued a \$2,000 refund check to them on 6/30/10. This refund is reflected on the July 15, 2010 Quarterly report on line 20c.


With regard to the second point in your letter regarding 48 hour notices, following is an explanation of the contributions in question:

Paid for by Portman for Senate Committee

1. Larry and Polly Nichols – This was an error in the data entry of these contributions. These two checks were dated May 1, 2010 but were actually received on May 3, 2010. When the contributions were input, they were input as the date of the check, not the date of receipt, which was May 3, 2010. The transactions have been corrected and reported as such on the amendment.
2. Christopher and Courtney Sarofim – These were in-kind contributions of catering for an event that was held in their home. The cost of the catering was over and above the home exemption. We did not have knowledge of the actual value of the in-kind until after the 48 hour notice period was over. We have amended the report to reflect the date we received the notification of the receipt of the in-kind contribution, May 11, instead of the date of the home event which was subject to the \$2,000 in-home exemption, which in and of itself would not have triggered any reporting obligation.


