This letter is prompted by the Commission's preliminary review of the report(s) referenced above. This notice requests information essential to full public disclosure of your federal election campaign finances. **Failure to adequately respond by the response date noted above could result in an audit or enforcement action.** Additional information is needed for the following 1 item(s):

- Your Amended Statement of Organization, received 4/5/16, included the language for both an independent expenditure only committee as well as a committee with a non-contribution account. Please amend your statement of organization to clarify this apparent discrepancy. If your committee was formed solely to make independent expenditures, please amend your Statement of Organization to include a statement clarifying this. An example of this statement can be found in Attachment A of Advisory Opinions 2010-09 and 2010-11 (a letter template is available at http://www.fec.gov/pdf/forms/ie_only_letter.pdf).

Alternately, if your committee has established a separate Non-Contribution Account, please amend your Statement of Organization to include a notification letter clarifying this. An example of this notification letter can be found at <http://www.fec.gov/press/Press2011/20111006postcarey.shtml>.

Please note, you will not receive an additional notice from the Commission on this matter. Adequate responses must be received by the Commission on or before the due date noted above to be taken into consideration in determining whether audit action will be initiated. Failure to comply with the provisions of the Act may also result in an enforcement action against the committee. Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to

taking enforcement action. **Requests for extensions of time in which to respond will not be considered.**

Electronic filers must file amendments (to include statements, designations and reports) in an electronic format and must submit an amended report in its entirety, rather than just those portions of the report that are being amended.
