This letter is prompted by the Commission's preliminary review of the report(s) referenced above. 1. You have failed to disclose the name and address of your committee on your Statement of Organization (FEC Form 1). Commission Regulations require that the Statement of Organization disclose the name, address, and committee type of the committee. Please amend your Statement of Organization to include the committee's name and address. (11 CFR 102.2(a)(i))
2. Your Statement of Organization does not include an email address for your committee. The Federal Election Commission sends Requests for Additional Information (RAI) as well as all courtesy mailings by electronic mail. In addition, mandatory electronic filers are required to provide an electronic mail address, if such an address exists. Please amend your Statement of Organization to disclose a current email address. (11 CFR §102.2(a)(1)(vii))
3. The Statement of Organization (FEC Form 1) that your committee submitted was not signed. Please re-submit your filing to include the proper signature. (11 CFR §102.2(a)(1))
4. You have failed to disclose name and address of your treasurer on your Statement of Organization (FEC Form 1). Commission Regulations require that the Statement of Organization disclose the name and address of the treasurer of the committee. Please amend your Statement of Organization to include the missing information. 11 CFR §102.2(a)

5. Your committee failed to designate a campaign depository on Line 9. Please be advised that each registered political committee must designate a campaign depository or depositories. The committee must maintain at least one checking account or transaction account at one of the depositories. Please amend your Statement of Organization (FEC Form 1) to disclose the committee's depository. (11 CFR § 102.2(a)(1)(vi) and 11 CFR §103.2)

**Please note, you will not receive an additional notice from the Commission on this matter.** Adequate responses must be received by the Commission on or before the due date noted above to be taken into consideration in determining whether audit action will be initiated. Failure to comply with the provisions of the Act may also result in an enforcement action against the committee. Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to taking enforcement action. **Requests for extensions of time in which to respond will not be considered.**

Electronic filers must file amendments (to include statements, designations and reports) in an electronic format and must submit an amended report in its entirety, rather than just those portions of the report that are being amended.
