Failure to comply with the previsions of the Act may also result in an enforcement action against the committee. Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to taking enforcement action.

-Your calculations for Line 11(d), Columns A and B appear to be incorrect. FEC calculations disclose this amount(s) to be \$138,197 and \$277,228, respectively. Please provide the corrected total(s) on the Detailed Summary Page.

-Your calculations for Line 19, Columns A and B appear to be incorrect. FEC calculations disclose this amount(s) to be \$138,197 and \$277,252, respectively. Please provide the corrected total(s) on the Detailed Summary Page.

-Your report discloses \$67 in total contributions refunded on Line 28(d), Columns A and B of the Detailed Summary Page. However, you have failed to itemize these refunded contributions on the appropriate lines of the Detailed Summary Page. Please amend your report to disclose the breakdown of this total on Lines 28(a), 28(b), or 28(c).

-The totals listed on Lines 11(c) and 11(d), Column B of the Detailed Summary Page(s) appear to be incorrect. Please be advised that you should add the "Calendar Year-to-Date" total from your previous report to the

current "Total This Period" figure from Column A to derive the correct Column B totals. Please amend your report and any subsequent reports that may be affected by this correction.

-Please provide a Schedule A to support the entry disclosed on Line 11(c) of the Detailed Summary Page. All contributions from political committees must be itemized on Schedule A regardless of the amount. 2 U.S.C. §434(b)(3)(B)

A response or amendment to your original report(s) correcting the above problem(s) should be filed with the Federal Election Commission within fifteen (15) days of the date of this letter. Electronic filers must file amendments (to include statements, designations and reports) in an electronic format and must submit an amended report in its entirety, rather than just those portions of the report that are being amended.
