Our office acts as campaign counsel for San Bernardino County Safety Employees' Benefit Association Local PAC (ID #C90014523). We are in receipt of your letter regarding our client's quarterly Report of Independent Expenditures Made and Contributions Received (FEC Form 5) covering the period from April 1, 2014 through June 30, 2014.

Your letter requests additional information regarding any contributors who made donations in excess of \$200 to fund the independent expenditures disclosed on our client's report. Federal regulations require a person filing FEC Form 5 to identify each person who made a contribution in excess of \$200 to the person filing the report if the contribution "was made for the purpose of furthering the reported independent expenditure." Please note, you will not receive an additional notice from the Commission on this matter. Requests for extensions of time in which to respond will not be considered. Failure to comply with the provisions of the Act may result in an enforcement action against the committee. Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to taking enforcement action.

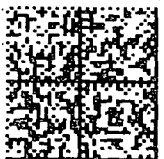
