Dear Mr. Gibson:

In reply to your Mailgram of yesterday, I enclose the Year End Report for Justice PAC.

The reason for the delay is twofold.

I suffered a catastrophic breakdown in the database program which contained all my data for Justice PAC. It wasn't a question of backing up the program, it was the program itself which crashed every time I would attempt to create the report I needed to fill out the Year End Report.

I flailed for several days trying to get the program to work and was finally advised that it was no longer compatible with the operating system on my computer. I had updated my operating system and was not aware that it would create this problem.

I had to reconstruct the data from original source material which I had placed in storage and I had to use a different database program which I had never used before.

I operate alone out of a home office. I have no assistants and no employees to help me in a situation like this. I was overwhelmed by the amount of time and work that it took to reconstruct my files and create the attached report.

In addition to the computer problems I lost the use of my voice, a situation which still exists as of this day, and I could not communicate by telephone with anyone. Needless to say, this made it very difficult to cope with the computer problems and very difficult to get advice on how to handle this situation.

In order to avoid this late filing problem in the future I will undertake whatever actions are necessary. I will hire an assistant to help with the reports. I will acquire new software to help with the filing of the reports and I will make an effort to follow any suggestions you have, including utilizing the electronic filing system that you have adopted.

I want to assure you that my only goal is to comply fully with the requirements of the law and with the regulatory requirements of the FEC.

I have been treasurer of Justice PAC from the beginning and have always made a good faith effort to satisfy all requirements.

The reports have gotten progressively more difficult to handle as the PAC has grown. I kept up with the filings but it was requiring much more time and effort than it did at first. Then I had a serious problem and it showed me that I didn't have an adequate back-up plan for dealing with a crisis.

I hope the steps I have taken will prevent any future occurrence of the late filing problem.
