Enclosed please find an amendment correcting the issues discussed in your letter. A contribution in the amount of \$1,000 made to Ashcroft 2000 on June 29, 1999 was erroneously reported for the Primary election. Also, while reviewing the report we noted a contribution dated June 30, 1999 to Dewine for Senate was mistakenly reported as \$2,000 for the Primary election but should be \$1,000 for the Primary and \$1,000 for the General election. 
