Enclosed are amended first and second quarter Federal Election Commission reports submitted on behalf of Caterpillar Inc.

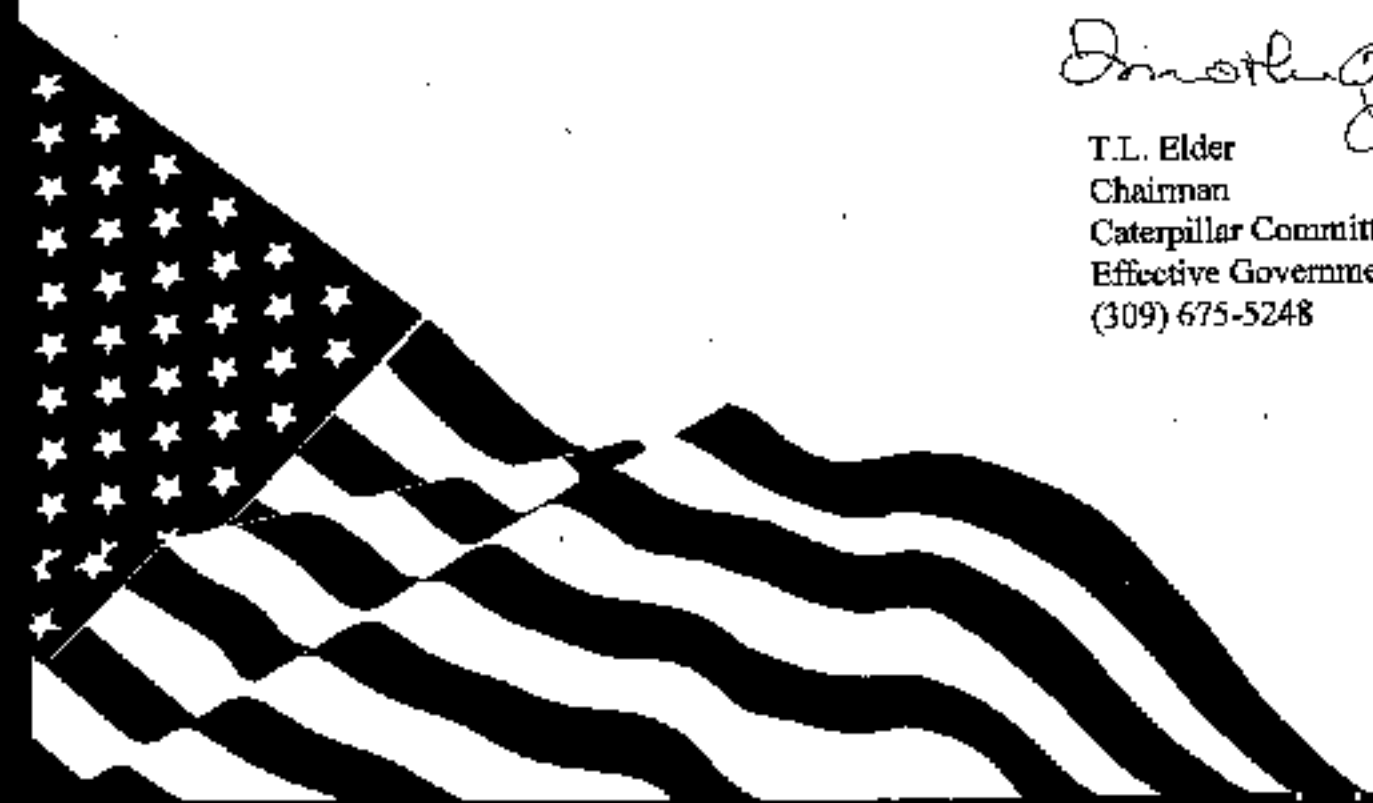
