The beginning cash balance was corrected 2. Calaculation on line 8 was corrected 3. Calculations for line 11a iii was column B was corrected 4. Identification of all individuals contributing in excess of \$200 was completed 5. On schedule B the 2010 election cycle was entered incorrectly as 2008 primary election. This was due to incorrect data entry, not the actual disbursements of contribution to candidates for the 2008 primary election. The mistake was corrected in this amendment and the correct cycle date of 2010 was entered.
