Dear Mr. Norfleet,

I am writing in reference to your request for additional information pertaining to our Committee's cash on hand at the time of registration, as listed in our 30 Day Post-General Report (10/22/08 - 11/24/08).

You have requested that I identify the source of these funds on a memo Schedule A. I have not been able to find a distinct "Memo Schedule A". Therefore, I am writing this memo and am attaching a Form 3x Schedule A with the supplementary details requested.

Our committee became required to file with the FEC for the very first time in October 2008. We submitted our Statement of Organization on October 22, 2008, and we filed an amendment to that Statement on January 2, 2009.

Many of funds we had on hand at the start of 2008 were accumulated and reflective of multiple, small (less than \$50, average \$35) donations from Committee members over the course of previous years. We began the year 2008 with an opening balance of \$920.21, as reported. By the beginning of the reporting period under examination, we had cash on hand of \$2,137.81. I assume you are looking for the details on the delta of \$1,217.60. A portion of that was actually reported specifically on Schedule A in our 30 Day Post-General Report (10/22/08 - 11/24/08).

In our 30 Day Post-General Report (10/22/08 - 11/24/08), I reported, on Schedule A, the details of a donation of \$857.88 which we had received prior to our Organization and prior to the reporting period. The date of that receipt was 08/05/2008. I have attached a photocopy of that previously-filed Schedule A for reference.

The remaining delta is \$359.72, which is comprised of many small donations from Committee members, plus one donation of \$100 from a Committee member. I am providing a memo Schedule A with the details of that donation, which was received on 02/02/2008, prior to our Organization and prior to the reporting period.

I tried calling you today to verify the adequacy of this supplementary memo report, but found that you are away until the 27th. I will call you on the 27th to determine whether any additional detail is required.
