
Copies of the enclosed correspondence will explain our delay in filing our report for the period July 2007 through December 31, 2007.

You can verify the Commission's receipt of any documents submitted by your committee on the FEC website at www.fec.gov.

The failure to timely file this report may result in civil money penalties, an audit or legal enforcement action. The civil money penalty calculation for late reports does not include a grace period and begins on the day following the due date for the report. Due to heightened security screening measures, delivery of mail by the US Postal Service may be delayed. The Commission recommends that you submit your report via overnight delivery or courier service.

I am writing in a desperate attempt to try and get some sort of response to a very frustrating problem.


In mid January we began leaving messages for the Electronic Filing Office. Calling daily and leaving messages. We had been trying unsuccessfully to download the 6.1.1.3 software so we could file our report on January 31, 2008 for the filing period July 1, 2007 through December 31, 2007. To this date we have never had any of those messages returned. We finally contacted our representative Kristin DeCarmine on January 30, 2008, a copy of that letter is enclosed.

On February 5, 2008 I finally was successful in contacting Sebene Smith who informed me that I needed to fill out a request form and fax it back to her and they would send the software. I returned the form within minutes of our phone call. Copies of that correspondence is also enclosed.

As of this date we have had no response from anyone much less received a copy of the required software. We are now almost three weeks late in filing our report and extremely frustrated at the lack of response we have received.


As discussed in my phone conversations with you this week, as of this writing we have been unable to get the Electronic filing office to return our phone calls requesting a copy of the new 6.1.1.3 software that is required for filing our report due tomorrow, January 31, 2008.

We have tried unsuccessfully to download the program but keep getting the same error message noting a compression error. The message says that when this method has been tried the only solution is to request a copy of the software from the Electronic filing technical support office. I have left several messages for them detailing our problem and requesting they call back so we can arrange to have the software sent via FEDEX, at our expense. As noted we have received no return call as yet. We will continue to call the technical support office daily and hope we can secure the software from them soon. As soon as it is in hand and we have it downloaded, we will file the report as quickly as possible.

Understanding these facts and pursuant to my conversation with you this date, the purpose of this letter is to document our efforts and serve notice that we may well be late filing the report for the period July 1, 2007 through December 31, 2007 due to these aforementioned problems. Additionally, I am sending a copy of the records we have here that serve as the basis for that report in an effort to at least file something in the spirit of meeting the deadline of midnight, January 31, 2008.

If there is anything you can do to assist us in our efforts to get a copy of the software, we would be grateful. I will continue to keep you advised of our efforts and receipt of the software when it arrives.
