This letter is prompted by the Commission's preliminary review of the report(s) referenced above. This notice requests information essential to full public disclosure of your federal election campaign finances. **An adequate response must be received at the Commission by the response date noted above.** An itemization of the information needed follows:

-Schedule A supporting Line 11(a)(i) of your reports disclose receipts identified as "Dues, Dues", "Payroll Deductions, Dues", and "SunTrust Bank Central Florida" (Transaction description: Payroll Deductions). Please be advised that federal regulations require the itemization of all contributions from individuals/persons that aggregate greater than \$200 in the calendar year. Contributions from individuals/persons that aggregate \$200 or less need only be disclosed on Line 11(a)(ii) of the Detailed Summary Page.

Please clarify whether the receipts disclosed on Schedule(s) A include any contributions that aggregate greater than \$200 from an individual/person in the calendar year. If this is the case, please amend your reports by itemizing the contributions from each individual/person on Schedule(s) A.
