This is to supply the information requested in your letter of August 7, 1996. We apologize for the delay in responding; it was due to the time required to ascertain and gather the information requested.


As requested, attached is a listing of each person who has contributed in excess of \$200 to the PAC since January 1, 1996.

We therefore attach amended reports for the first and second quarter of 1996 reflecting that fact, and would note as well that as a consequence no limitation was exceeded.
