I am the Treasurer of the PAC, and this is our first report since our inception (we were created as an entity in Q1 but had no receipts or disbursements). Because I did not understand the level of detail required by the report, I started it too late to complete on time and will be filing an amended form as quickly as possible.

The information regarding our total receipts and disbursements is accurate, but there is no detailed information regarding our donors included in this filing. We do have the information, but I started preparing the report too late to gather it. Every contributor is an employee of Cbeyond, and—with just a few exceptions—every contribution has been made via a payroll deduction. With several possible exceptions involving high-ranking officers of the company, no contributions involve more than \$250 in aggregate for any one individual.

I apologize for not filing a complete report and can assure you that this will not recur. I will file an amended report as quickly as possible to provide the additional information. Please contact me if you need any additional clarification.
