-The Summary Page discloses \$1,500 on Line 7, but the Detailed Summary Page shows the Line 30 total to be omitted. These figures should be the same. Please amend your report accordingly.

-Please provide the totals for Lines 11(a)(iii), 11(d) and 19, Column B of the Detailed Summary Page. Note that changes in your figures may affect your Column B totals on this report and/or on subsequent reports.

-Please provide the total(s) for Line 30, Columns A and B of the Detailed Summary Page. Note that changes in your figures may affect your Column B totals on this report and/or on subsequent reports.

-Please amend Schedule B supporting Line 23 by providing the election designation for each contribution made to a federal candidate or political committee. 11 CFR §§104.3(b)(3)(ii) and (v)
