Upon discovery, though after qualification requirements were met, PAC filed Form 1 M and contacted the campaign and re-designated the original contribution as (a) \$2400 for the general election (maximum permitted at time of original contribution), (b) \$2400 for the recount effort (the maximum that would have been permissible for the recount had it been held at the time of the original contribution), and (c) a \$200 refund, received and deposited in January 2011.
