(5) Contributions by spouses and minors.

(1) The limitations on contributions of this section shall apply separately to contributions made by each spouse even if only one spouse has income.

(2) Minor children (children under 18 years of age) may make contributions to any candidate or political committee which in the aggregate do not exceed the limitations on contributions of this section, if—

(i) The decision to contribute is made knowingly and voluntarily by the minor child;

(ii) The funds, goods, or services contributed are owned or controlled exclusively by the minor child, such as income earned by the child, the proceeds of a trust for which the child is the beneficiary, or a savings account opened and maintained exclusively in the child's name; and

(iii) The contribution is not made from the proceeds of a gift, the purpose of which was to provide funds to be contributed, or is not in any other way controlled by another individual.

(j) **Application of limitations to elections.** (1) The limitations on contributions of this section shall apply separately with respect to each election as defined in 11 CFR 100.2, except that all elections held in a calendar year for the office of President of the United States (except a general election for that office) shall be considered to be one election.

(2) An election in which a candidate is unopposed is a separate election for the purposes of the limitations on contributions of this section.

(3) A primary or general election which is not held because a candidate is unopposed or received a majority of votes in a previous election is a separate election for the purposes of the limitations on contributions of this section. The date on which the election would have been held shall be considered to be the date of the election.

(4) A primary election which is not held because a candidate was nominated by a caucus or convention with authority to nominate is not a separate election for the purposes of the limitations on contributions of this section.

(k) **Joint contributions and reattributions.** (i) Any contribution

made by more than one person, except for a contribution made by a partnership, shall include the signature of each contributor on the check, money order, or other negotiable instrument or in a separate writing.

(2) If a contribution made by more than one person does not indicate the amount to be attributed to each contributor, the contribution shall be attributed equally to each contributor.

(3)(i) If a contribution to a candidate or political committee, either on its face or when aggregated with other contributions from the same contributor, exceeds the limitations on contributions set forth in 11 CFR 110.1 (b), (c) or (d), as appropriate, the treasurer of the recipient political committee may ask the contributor whether the contribution was intended to be a joint contribution by more than one person.

(ii) A contribution shall be considered to be reattributed to another contributor if—

(A) The treasurer of the recipient political committee asks the contributor whether the contribution is intended to be a joint contribution by more than one person, and informs the contributor that he or she may request the return of the excessive portion of the contribution if it is not intended to be a joint contribution; and

(B) Within sixty days from the date of the treasurer's receipt of the contribution, the contributors provide the treasurer with a written reattribution of the contribution, which is signed by each contributor, and which indicates the amount to be attributed to each contributor if equal attribution is not intended.

(l) **Supporting evidence.** (1) If a political committee receives a contribution designated in writing for a particular election, the treasurer shall retain a copy of the written designation, as required by 11 CFR 101.1(b)(4) or 110.2(b)(4), as appropriate. If the written designation is made on a check or other written instrument, the treasurer shall retain a full-size photocopy of the check or written instrument.

(2) If a political committee receives a written redesignation of a contribution for a different election, the treasurer shall retain the written redesignation provided by the contributor, as re-

quired by 11 CFR 110.2(b)(3), as appropriate.

(3) If a political committee's written reattribution of a contribution to a different contributor shall retain the reattribution signed by the contributor, as required by 11 CFR 110.2(b)(3).

(4) If a political committee fails to rely on a postmark indicating the date on which a contribution was made, the treasurer shall retain the original contribution envelope or a copy of the envelope, including the postmark, as supporting information.

(5) If a political committee retains the written reattribution required by 110.1(c)(2), the contribution shall be considered to be designated for a particular election as defined in 11 CFR 100.2. (6) If a political committee does not retain records concerning a contribution required by 110.1(c)(2), (3) or (4), the contribution shall not be considered to be designated for a particular election as defined in 11 CFR 100.2. (7) For each written reattribution or written redesignation as described in paragraph (k)(3) of this section, the political committee shall retain a copy of the reattribution or redesignation or written record. Such records shall consist of:

(i) A copy of the original contribution envelope, including the postmark and the contributor's name and return address or zip code; or

(ii) A copy of the written reattribution or written redesignation, including the date stamp indicating the committee's receipt; or

(iii) A copy of the written reattribution or written redesignation of the contributor.

(m) **Contributions to state and local committees.** (1) Contributions for the purpose of their selection under 11 CFR 110.2 are not subject to the limitations of this section.

(2) Contributions to political committees under 11 CFR 110.2 are subject to the limitations of this section.
