Enclosed please find an executed copy of FEC Form 1, which requests a name change for the entity formerly known as TRCPAC to DAVITA PAC.

In late fall 2000, TRC, a provider of dialysis services for patients suffering from chronic kidney failure, changed its name to Davita, an Italian phrase meaning "he/she gives life." The name change was one component of a multi-year turnaround focusing on improving the company's financial and operational infrastructure.

Due to the complexities and time constraints of the turnaround, this form was not been filed within the 10 day period required by the Commission. However, Davita wishes to come into complete compliance, and asks that the difficult facts and circumstances surrounding the turnaround be considered in evaluating its name change request in the attached Form 1. Also this week, a request to issue checks has was filed under separate cover.
