To whom it may concern:

I was appointed Treasurer for the Brush Engineered Materials Good Government Fund (BrushPAC) as of July 2001. Since that time, I have identified several errors in the accounting/reporting of the fund balance that require immediate adjustments for year-end. These include:

- Adjustment for \$1,517.74 in payroll withholdings for the period February 1997 through December 2001 that had not been properly remitted to the BrushPAC escrow account. As a result of this oversight, it appears this withholding amount was not properly disclosed on prior FEC report filings. The entire amount represents withholding for only one employee (Peter F. Lynch) located at our Rhode Island plant. This amount has been recently remitted to the fund's escrow account in January 2002.
- Adjustment of \$1,250.00 to correct the error in the fund balance previously reported on the 12/31/01 FEC Annual Report.
- Also be advised that effective immediately the *Brush Wellman Good Government Fund* had changed its name to *Brush Engineered Materials Good Government Fund, (also known as BrushPAC)*. The change is due to the legal reorganization of the company that took place during 2000, but was not properly reported to you. I have enclosed a new Statement of Organization Form identifying this change.

To assist you, I have submitted a separate schedule reconciling and identifying these corrections to properly reflect our PAC account balance at 12/31/01. **The balance in the BrushPAC fund at 12/31/01 should be \$17,139.93.**

I believe the errors above were unintentional oversights and a result of the high turnover of Treasurers and committee members over the past several years. I believe that I have to the best of my abilities identified and corrected all the errors. Accordingly, I have included the amounts on the FEC Form 3X filing to properly reflect the BrushPAC fund balance for the year ended 12/31/01. Unfortunately, I cannot determine exactly when these errors took place without doing extensive research.
