I am in receipt of your letter dated July 5, 2006. As you know, we did an amendment on July 19 on report FEC 222780 (the May report that was filed on June 20<sup>th</sup>.)

We have not made an excessive contribution to the NRCC. HotelPAC initially cut a check to the NRCC for \$10,000 on 4/6/06. Unfortunately, due to an administrative error, the check was mistakenly sent to the campaign office of Reynolds for Congress. Reynolds for Congress was somehow able to deposit the check even though it was clearly made out to the NRCC. When Reynolds for Congress became aware of the mistake, they contacted us and promptly refunded the funds to us which we deposited back into our HotelPAC account.

Per your request, our amended report shows a receipt of \$10,000 on 5/17/2006 from the NRCC to show that our original disbursement was returned to us on 5/17/2006 when the mistake was discovered. Our amended report also shows a disbursement for \$10,000 on 5/17/2006 to the NRCC to show that we then re-cut the check to replace the original disbursement sent on 4/6/2006 that was never received by the NRCC.

HotelPAC 2006 disbursements to the NRCC total \$10,000 and we apologize any confusion.
