DEAR MR DODSON:


I AM RESPONDING TO YOUR LETTER REFERENCING OUR MID-YEAR (1/1/93-6/30/93) AND

OF ONE OF THE CONTRIBUTING COMMITTEE AND AM NOT AWARE OF ANY
REQUIREMENT FOR US ON THE COUNTY LEVEL TO REGISTERED WITH YOU.

THE SOURCES OF THE FUNDS OF THIS COMMITTEE HAVE NOT BEEN QUESTIONED IN THE
PAST AND I AM CURIOUS AS TO THE TIMING OF THIS INQUIRY. THEY HAVE BEEN
REPORTED IN THIS CONSISTENT MANNER FOR MY TERMS AS TREASURER, AND FROM THE
INCEPTION OF THIS COMMITTEE.
