This letter is in response to the Federal Election Commissions letter dated July 20, 2007 requesting additional information regarding our Amended April Quarterly Report. There were discrepancies in Column B and Column A figures from our previous report to this before mentioned report. We were asked to file amendments to our reports to correct the Column B discrepancies for Line(s) 11(a)(iii), and 11 (c), and all subsequent reports which might be affected by the correction.

When looking for the mistake I found that we had a data entry mistake in our Post General Report (10/19/06-11/27/06). This is the report that was filed before the Year End Report and due to the data entry mistake it made our numbers off. In our Post General Report, Citizens Against Government Waste was entered as an Individual not a PAC. It printed in our report as an individual and threw off our numbers for Lines 11(a)(iii) and 11(c).

Subsequently before our Year End Report was filed I found and changed the mistake to read as a PAC. Our Year End Report and Amended April Quarterly Report numbers are correct for the Detailed Summary Report Pages. The mistake is in the Post General Report.

To take corrective action I have filed under another copy an amendment to our Post General Report and now our Summary Pages are equal.

An adequate response must be received at the Senate Public Records Office by the response date noted above. Failure to adequately respond by the response date noted above could result in an audit or enforcement action. Additional information is needed for the following item:

-Column B figures for the Summary and Detailed Summary Page information should equal the sum of the Column B figures on your previous report and the Column A figures on this report. Please file an amendment to your report to correct the Column B discrepancies for Line(s) 11(a)(iii), 11(c), and <u>all subsequent report(s) which may be affected by this correction</u>. Note that Column B should reflect only the election cycle-to-date totals. (2 U.S.C. § 434(b))

Please note, you will not receive an additional notice from the Commission on this matter. Adequate responses must be received by the Commission on or before the due date noted above to be taken into consideration in determining whether audit action will be initiated. Failure to comply with the provisions of the Act may also result in an enforcement action against the committee. Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to taking enforcement action. 
