- Schedule B of your report discloses reimbursements to individuals for "PHONE EXPENSE REIMBURSEMENT," "PHONE EXPENSE & OFFICE EQUIPMENT REIMBURSEMENT," "OFFICE SUPPLY & PARKING REIMBURSEMENT," "FUNDRAISING/EVENT TRAVEL REIMBURSEMENT," and "OFFICE EXPENSE & PARKING REIMBURSEMENT." Please be advised that when itemizing reimbursements to individuals for goods or services, if the payment to the original vendor aggregates in excess of \$200 in a calendar year, a memo entry including the name and address of the original vendor, as well as the date, amount and purpose of the original purchase must be provided. Please amend your report to include the missing information and clearly identify on the Schedule B, which reimbursement each memo entry relates to. If itemization is not necessary, you must indicate so in an amendment to this report. 11 CFR §§104.3(b)(3)(i) and 104.9, and Advisory Opinions 1992-1 and 1996-20, footnote 3

Please note, you will not receive an additional notice from the Commission on this matter. Adequate responses must be received by the Commission on or before the due date noted above to be taken into consideration in determining whether audit action will be initiated. Failure to comply with the provisions of the Act may also result in an enforcement action against the committee. Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to taking enforcement action. **Requests for extensions of time in which to respond will**
