Dear Ms. Kang:

I am writing to detail corrective action taken by the S. C. Johnson & Son, Inc. Political Action Committee to address issues you've raised concerning our October Quarterly Report (7/1/00 - 9/30/00) and our 30-day Post-General Report (10/19/00 - 11/27/00). Please note that our FEC Identification Number is C00342246.

The issues relate to three candidates to whom our political committee made contributions:

- Representative Sherwood Boehlert
- Senator Spencer Abraham
- Representative Robert Goodlatte

Actions taken to address reporting issues raised in your letters are as follows:

Representative Boehlert - A contribution to Rep. Boehlert's primary campaign made on 10/14/99 was incorrectly labeled as a contribution for the general campaign. A copy of the corrected form is attached (Exhibit A). Two contributions of \$500 each to Mr. Boehlert's general campaign on 7/26/00 and 10/4/00 which are correctly labeled, are also attached.


Senator Abraham - A contribution to Senator Abraham's primary campaign on 2/17/00 was incorrectly labeled as a contribution for the general campaign. A copy of the corrected form is attached (Exhibit B). A contribution of \$1,000 to Senator Abraham's general campaign on 8/11/00 which is correctly labeled, is also attached.

Representative Goodlatte - A contribution to Representative Goodlatte's primary campaign on 1/27/00 was incorrectly labeled as a contribution to the general campaign. A second contribution to Representative Goodlatte's general campaign dated 10/24/00 was not labeled. Both errors have been corrected on the forms found in Exhibit C.
