Please clarify the contribution(s) and disclose any redesignations or refunds as necessary on the appropriate schedules.

-Your report(s) was not signed by the treasurer or designated agent listed on your Statement of Organization. Please amend your report(s) by providing the signature of an individual that is authorized to sign the report(s). 2
