1. Schedule H4 supporting Line 21(a) discloses a refund of a disbursement made to "Investec Management Corporation Trust Account for Golden State Holdings." However, it appears that the original disbursement(s) was not previously reported by your committee. Please amend the appropriate report(s) to disclose the original contribution or provide clarifying information. (2 U.S.C. § 434(b) and 11 CFR § 104.3(a) & (b))

- For your information and consideration when preparing future filings, please be advised that Schedule H2 is used for shared federal and non-federal fundraising and direct candidate support activity. The ratio for shared administrative expenses is derived from Schedule H1 and should not be included on your Schedule H2.

Please note, you will not receive an additional notice from the Commission on this matter. Adequate responses must be received by the Commission on or before the due date noted above to be taken into consideration in determining whether audit action will be initiated. Failure to comply with the provisions of the Act may also result in an enforcement action against the committee. Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to taking enforcement action. **Requests for extensions of time in which to respond will**
