To Whom It May Concern:

This letter responds to the Federal Election Commission's request for additional information dated March 22, 2016, regarding the Amended October Quarterly Report (07/01/2015-09/30/2015) filed by Kamala Harris for Senate ("Committee"), and received by your office on March 9, 2016. The letter requested additional information on two items:

1. The letter requests clarifying information as to why additional debts included on the amended report were not disclosed on the original report. The Committee has policies and procedures in place for requesting vendor invoices, consistent with the FEC's Best Practices for Committee Management. Nonetheless, the relevant invoices were not received until after the due date for filing the original report. The Committee amended its report immediately upon becoming aware of the outstanding invoices.
2. The letter requests that an amendment be filed correcting the Column B totals of the Summary Page and the Detailed Summary Page. The Committee, in fact, corrected those totals in its amendment filed on March 9, 2016, prior to receiving the Commission's letter.
