The Committee disclosed payments for Salaries/Wages for this period on Schedule H4 for Line 21a, and Schedule B for Line 30b. The Committee paid its employees with 100% federal funds, and disclosed the expenditures on Line 30b when the individual spent more than 25% of their compensated time in a given month on Federal election activity or activities in connection with a Federal election. Those individuals who spend 25% or less of their compensated time in a given month on Federal election activity or activities in connection with a Federal election are paid with Federal funds, and allocated on Schedule H4. These items included, but are not limited to pens, paper, paper clips, pencils, ink, toner, video tapes, CDs, cups, toilet paper, paper towels, tissues, trash bags, coffee, tape, extension cords, light bulbs, labels, folders, organizers, envelopes, cartridges, soap, cleaning products, etc. Original expenditures for offsets reported on Line 15 of the Committee's report were all paid for with 100% federal funds and were not allocable.
