The transactions from National Media were returns of unused funds from a media vendor. Please see, for example, the October 2006 Monthly Report.



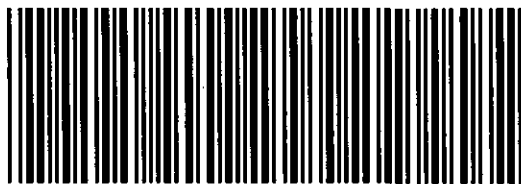
