The Committee takes the following actions regarding contributions with a foreign address. Contribution solicitations from direct marketing or from fundraising events request that the donor sign a statement verifying the money is from their personal funds and that they are a U.S. Citizen or "green card" holder. The Committee's website contains a statement similar to that above that the donor is required to affirm before the web portal will process the contribution.

When the Committee receives a contribution from a donor with a foreign address, it sends a follow up letter via regular mail or via email requesting that the donor verify they are a U.S. Citizen and affirming that they are not prohibited from contributing. If the committee has any information indicating the contribution is impermissible, a refund is issued within 30 days of the committee making this determination.
