1. Your amended report discloses a decrease in receipts totaling \$51,999 from the amounts disclosed on your original report. Please amend your report or provide an explanation to clarify why this additional activity was not provided with your amended report. (11 CFR § 104.3)
2. The beginning cash balance of this report does not equal the ending balance of your 30 Day Post-General Report (10/15/20 - 11/23/20). Please correct this discrepancy and amend all subsequent report(s) that may be affected by the correction. (52 U.S.C. §30104(b))

**Please note, you will not receive an additional notice from the Commission on this matter.** Adequate responses must be received by the Commission on or before the due date noted above to be taken into consideration in determining whether audit action will be initiated. Failure to comply with the provisions of the Act may also result in an enforcement action against the committee. Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to taking enforcement action. **Requests for extensions of time in which to respond will not be considered.**

Electronic filers must file amendments (to include statements, designations and reports) in an electronic format and must submit an amended report in its entirety, rather than just
