This report is being filed at the direction of the FEC analyst, covering the period from October 1, 2015 through December 31, 2015, and designated as an January 31 Year-End Report and a termination report.

The original termination report was filed on January 5, 2015, for the period ending December 31, 2014, showing the cash balance was \$0.00, with no debts or obligations owed to the Committee or by the Committee.

Apparently, due to a coding error, the original termination report was not processed as a termination report. Between the filing of the first termination report and the second termination report, a complaint was filed against all Democratic Party Committees and Democratic candidates who ran for U S Congress in the 2015 elections.

Because the FEC failed to act on the first termination report prior to the complaint being filed, subsequent Quarterly "zero activity and zero balance" reports as Termination reports must be filed until the complaint is resolved, although the Committee bank account was closed prior to January 5, 2015, the committee has no debts or obligations, and no contributions or disbursements have occurred since December 31, 2014.
