Re: Memo Item on Disbursement of Receipts Incorrectly Directed to IWPA PAC Account

As reported in our March 20, 2023 filing, an error in routing non-PAC contributions via our merchant services provider on February 14, 2023, resulted in four transactions having been incorrectly deposited in IWPA PAC's Wells Fargo account.

The four receipts totaling \$6,000.00, which were reported on Line 17 of IWPA's March 20<sup>th</sup> Report of Receipts and Disbursements and itemized using Schedule A, were observed on March 15 and immediately transferred to the appropriate non-PAC account.

On March 15<sup>th</sup>, \$6,000.00 was transferred to one of IWPA's non-PAC accounts at Wells Fargo. This disbursement was reported on Line 29 of this report.






