This letter is prompted by the Commission's preliminary review of the report(s) referenced above. The review raised questions concerning certain information contained in the report(s). An itemization follows:

-A review of the reports filed by your committee (pertinent portion(s) attached) indicate that your committee received a \$6,096 transfer-in from the Democratic National Committee (DNC); however, a review of the donor's reports indicate that it only transferred-out \$2,996. Please amend your report to clarify this apparent discrepancy.

-Schedule H2 of your report discloses activity which is 100% federal. For future reporting, please be advised that activity which is financed entirely by the federal account should not be reported on the H Schedules.


-Schedule H2 of your report indicates that your committee participated in fundraising activities or events during the reporting period. However, there are no corresponding disbursements reflected on your Schedule H4. If any disbursements were incorrectly reported, you should file an amended Schedule H4 with the correct unique identifying code or title.

Note that you need not include activities on Schedule H2 if there are no corresponding payments made for the activity during the reporting period.
