Dear Ms. Carter:

We are in receipt of your Request for Additional Information dated January 14, 2013 regarding contributions made to Tommy Thompson for Senate, Inc. At the time of the contributions, PharmAthene, Inc. Political Action Committee mistakenly believed that we had met the criteria to qualify for multicaudidate PAC status. A subsequent review of our records shows that we have not yet met the criteria.

To rectify our mistake, we have taken the following actions:

- With respect to our July 2, 2012 contribution to Tommy Thompson for Senate, Inc. designated towards the Primary election, we have requested that the committee refund \$500.
- With respect to our September 18, 2012 contribution to Tammy Thompson for Senate, Inc. designated towards the General election, we have requested that the committee refund \$2,500.

Enclosed, you will find a copy of our letter to Tommy Thompson for Senate, Inc. seeking a refund of \$3,000 for the Primary and General elections. Once we have received any refunds, we will report them on Line 16 of Schedule A of the report covering the period during which the refunds are received.
