Dear Mr. Furman,

In response to your letter dated April 22, 2015 for more information on three items.

1.) We have reviewed our procedures and found that though we attempted to transmit the needed information, it did not transmit to the FEC.

The Committee is in the process of shutting down and will not be transmitting any 48 hour Reports in the future.

All of the 48 hour contributions that are missing were reported on the Post General Report and do not change our contribution totals so we did not need to amend the report.

2.) The Committee transmitted the information twice to the FEC, believing it had not been successful after the first transmission. The two occurred one minute apart and since the information was only reported once on the Post General Report, and did not change the number of contributions, we did not need to amend the report.

3.) The debts in question were reported on earlier reports, in the disbursements section, but were not updated in the Debts and Obligations section until the Post General Report.

Best Buy charge for \$470.13 was a VISA charge incurred in August of 2014 and paid off within our 10/7/14 VISA payment.

Qualified Presort for 470.13 was paid off by check on 9/29/14.


Robodial for 202.39 was incurred on 2/5/14 and paid off 4/3/14 within our VISA payment.






