Enclosed, please find an amended Year End Report of Receipts and Disbursements covering the period (7/1/99-12/31/99). This amendment is being filed pursuant to your October 24, 2001 letter to Edward R. Comstock, Treasurer of Reed Elsevier Inc. Political Action Committee. Your letter indicates that Reed Elsevier Inc. PAC made an excessive contribution to DeWine for U.S. Senate because it had not yet qualified as a multi-candidate committee at the time it made the contribution.



"Primary 2000." Your letter also references the DeWine Committee contribution which was made on 8/1/00 and reflected on the October Quarterly Report (7/1/00-9/30/00). This contribution was correctly designated as "General 2000."

Please note that Reed Elsevier Inc. PAC has received a refund of \$1,000 from the DeWine Committee which represents the second \$1,000.00 contribution that Reed Elsevier PAC contributed to the DeWine Committee. Reed Elsevier Inc. PAC will report that refund on the 2001 Year End Report of Receipts and Disbursements. Having received this refund, the amounts actually given by Reed Elsevier Inc. PAC to the DeWine for U.S. Senate Committee during the 2000 election cycle are: \$1000.00 for the 2000 primary election and \$500.00 for the 2000 general election. Additionally, please note that Reed Elsevier Inc. PAC has qualified as a multi-candidate committee and has filed its 1M Statement under separate cover.


