

Dear Mr. Krebs:

I am in receipt of your letter of November 28, 2001, to Duane Thompson, Treasurer of the Financial Planning Association Political Action Committee (FPA-PAC). As Assistant Treasurer and the "organizer" of FPA-PAC, I wish to clarify our Statement of Organization with regard to the relationship with the International Association of Financial Planning Political Action Committee (IAFP-PAC). The International Association of Financial Planning is the predecessor organization of the Financial Planning Association. When I began the process of organizing FPA-PAC, I inquired with the FEC Information Division whether IAFP-PAC should be renamed FPA-PAC or FPA-PAC should be created as a new committee and the funds from IAFP-PAC transferred. I was advised to do the latter and to designate IAFP-PAC as a connected organization and list the relationship as a transfer. IAFP-PAC has dissolved or is in the process of dissolving as a federally recognized political action committee. If I was incorrectly informed in this procedure, I will be happy to correct any error. I have enclosed an updated copy of FEC FORM 1 as an amendment.


