Friends of Democracy's Post General 2012 Filing has Schedule E expenditures that differ from the 24 Hour Reports filed for that period in several ways, as listed below. The expenditures reported on Schedule E are correct.

TECHNICAL LIMITATIONS DO NOT CURRENTLY ALLOW US TO FILE AMENDED 24 HOUR REPORTS which delete or change items contained

in the reports as originally filed. So we are requesting that the amended 24 hour Report filings noted below, be considered the REPLACEMENTs for the originally filed 24 Hour Reports, as noted below. The amended 24 Hour Reports are

meant to correct reports originally filed for October 25 (see A below), and October 31 (see B below).

A) On October 25, 2012 Friends of Democracy filed two 24 Hour-Indepent Expenditure Reports, one at approximately 4 pm and the other at approximately 7 pm. The later report erroneously included the earlier reports expenditures. This created the appearance of having made the expenditures twice, and therefore did not match the correctly itemized expenditures reported on Schedule E of our Post-General 3X Filing. The amended report filed April 24, 2013 (FEC # 868850) should be considered the replacement for the previously filed reports, FEC # 826964 & 827852.

B) On December 20, our committee filed a new 24 Hour Report for the following 2 expenditures made on October 31, 2012. An Amended Report was filed on December 21, 2012 which included the expenditures again, while also amending an amount

originally reported on October 31 for an expenditure not included on the 12/20 filing. The amended report filed December 21 (FEC # 842898) has the correct expenditures, and should be considered the replacement for FEC report # 842843 filed 12/20/12 and FEC report # 8304480 filed 10/31/12 and amended 11/12/12.
