This letter is in response to your letter of July 15, 2005.


DCRP-MPAC is a separate fund set up by the Executive Committee of the Denton County Republican Party. Under both 11 CFR 100.5(g) and 11 CFR 110.3, we are NOT affiliated with the Republican Party of Texas or the Republican National Committee.

Under Texas state law, the membership of the executive committee of the Denton County Republican Party (DCRP) is made up of the elected Republican precinct chairmen of Denton County and the elected County Republican Chairman of Denton County. There is no overlap of officers between the DCRP and any state or national party. Under 11 CFR 110.3(b)(3), the DCRP has not (i) received any funds from any other political committee and (ii) "...does not make its contributions in cooperation, consultation or concert with...any other party unit of political committee", therefore rebutting the presumption of 11 CFR 110.3(b)(3).

Because of the foregoing, Question 5 of the FEC Form 1, as filed, is correct.

Question 6 was left blank by mistake. A corrected page 2 of FEC Form 1 is enclosed.

Dear Mr. McCombs:

This letter is prompted by the Commission's preliminary review of the report(s) referenced above. This notice requests information essential to full public disclosure of your federal election campaign finances. **An adequate response must be received at the Commission by the response date noted above.** An itemization of the information needed follows:

-Your committee has checked Line 5(f) which indicates that your committee supports/opposes more than one Federal candidate, and is not a separate segregated fund or a party committee. However, it appears your committee may be a party committee. If your committee is responsible for the day-to-day operation of a political party, then you should complete the required information for Line 5(d). Further, you are advised that Line 6 should be used to disclose the name of any affiliated or connected organization (not the apparent name of your party committee). Please amend your Statement of Organization to clarify these apparent discrepancies.

-Please clarify your relationship, if any, with Republican Party of Texas, which appears to be an affiliated committee. For further guidance on the question of affiliation, please refer to 11 CFR §100.5(g) and §110.3. If your committee is affiliated with Denton County Republican Party you should amend your Statement of Organization to reflect this relationship as "affiliated" on Line 6.



Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to taking enforcement action.
