
This letter is to address the issues mentioned in your November 24, 2004 letter. The totals listed on Lines 6c, 7, 11(a)(iii), 11(d), 19, 20, 29, 31 and 32, Column B of the Summary and Detailed Summary Page(s) were all reconciled after the July 15 Quarterly Report was sent electronically to you December 15.

To reiterate, the problem with the October 15 Quarterly Report was that the July 15 Quarterly Report that the National Chicken Council filed electronically was not received by you in its entirety. The Itemized Disbursements Schedule B was somehow dropped off the report. Thus, all subsequent reports we filed were incorrect.

We received your confirmation by phone on December 16, that the complete July Quarter Report was received by the Federal Election Commission, and that all subsequent totals and reports are correct.

To ensure that this does not happen again, we will check electronically to see what the FEC received from the National Chicken Council, after each report is sent.
