
In response to your letter, referenced above, we have filed with the Secretary of the Senate, an amended April Monthly Report (3/1/03-3/31/03) providing: (1) clarification of the type of equipment purchased; and (2) the complete address for each disbursement itemized on Schedule B supporting lines(s) 21(b).

With respect to Schedule A supporting Line 15, please be advised that all payments received from federal candidate committee(s) for goods and services provided by this Committee, are at the usual and normal charge for the goods and services provided. With respect to Rent/Occupancy, our Committee charges candidate committee(s) the prevailing commercial rent for comparable rental space.

Regarding memo Schedules A's from Washington Senate 2002, a joint fundraising committee, we have previously advised the Commission, that the Democratic Senatorial Campaign Committee discloses its memo entries from its affiliated committees on a monthly reporting cycle and reports its transfers-in on Line 12 based upon the dates the dollars are actually received. Thus, a memo entry will be included in the Committee's report if dollars were contributed in that period to the affiliated committee. However, dollars from the affiliated committees are transferred only periodically to the Democratic Senatorial Campaign Committee, thus there is no direct relationship between the dollars on the monthly memo entries and the dollars reported as received on Line 12.
