MISCELLANEOUS TEXT (FEC Form 99)

This is a response to the FEC's November 17, 2015 RFAI requesting information from Murray Energy Corporation PAC regarding a refund request for an inadvertent excessive contribution to the Ohio Republican Party on June 20, 2015.

After noticing the \$10,000 contribution exceeded the \$5,000 contribution limit to a state, district, or local party committee, Murray Energy Corporation PAC requested a \$5,000 refund via telephone in late June 2015. A \$5,000 refund check from the Ohio Republican Party (check #17238) was received on November 9, 2015. A copy of the refund check will be mailed to the FEC and the refund will be reported on Murray Energy Corporation PAC's next year-end report due January 31, 2016.

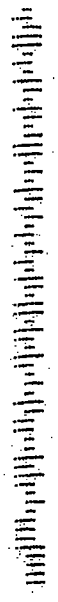
