A preliminary review by the Federal Elections Commission has determined that the contribution may have exceeded the allowable limit for a non-multi-candidate political action committee pursuant to Act. 2 U.S.C. § 441a(a). Since the date of the California primary election pre-dated the contribution, we unfortunately must ask for a refund in the amount of \$1,000.00 payable to "Carolyn's PAC". Please forward the check directly to the Committee Treasurer, Clifton H.W. Maloney, 49 East 92nd Street, #1A, New York, NY 10128.

However, should your committee have primary election debts in the amount of \$1,000.00 or in excess of that amount at the time the contribution was made, you may be able to reattribute it to "Disbursement 2002 Primary". Please advise us in writing with the
