Enclosed is an amended monthly report for August 2016, covering the period from 07/01/2016 -07/31/2016. This filing corrects a transcription error in the FEC database that shows Smith & Nephew Inc. PAC (C00374066) having contributed \$10,000 to The Niki Tsongas Committee (C00433136) with a disbursement date of July 8, 2016. While our original submission correctly showed a \$1,000 contribution, the handwriting was somewhat unclear.

Per a June 27, 2017 conversation with Mr. Quy Vuong, Senior Campaign Finance & Reviewing Analyst, we are submitting an amended report so that the error in the database may be more easily corrected. For reference, I am attaching a print out from the database for the contribution in question.


