Dear Treasurer:

This letter is prompted by the Commission's preliminary review of the report(s) referenced above. This notice requests information essential to full public disclosure of your federal election campaign finances. **Failure to adequately respond by the response date noted above could result in an audit or enforcement action.** Additional information is needed for the following 2 items:

1. Line 6 of the Summary Page of your report discloses a total of \$54,227,423.93 in Total Donations Accepted. The sum of the entries itemized on Schedule 13-A, however, indicates the total to be \$46,333,035. Please amend your report to clarify the discrepancy.
2. Schedule L-B supporting Line 6 discloses a refund of a contribution received from (see attached). However, it appears that many of the contributions were reported as \$0.00 on Schedule L-A. Please be advised that a committee must report the original contribution amount as received by the committee. Please amend the appropriate report(s) to disclose the original date and contribution amount on Schedule 13-A supporting Line 6 of the Detailed Summary Page.

Please note, you will not receive an additional notice from the Commission on this matter. Adequate responses must be received by the Commission on or before the due date noted above to be taken into consideration in determining whether audit action will be initiated. Failure to comply with the provisions of the Act may also result in an enforcement action against the committee. Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to taking enforcement action. **Requests for extensions of time in which to respond will not be considered.**
