However, we subsequently discovered that we used the same vendor to generate this mailing as the campaign of the ultimate beneficiary candidiate whose opponent our mailer was in opposition to. Because we relied on the vendor to some extent in preparation, and do not have a firewall in place, we cannot rule out an inadvertant act of coordination having occured. Upon consultation with our FEC Analyst, we are reporting this transaction as memo text on line 21(b) and as a contribution on line 23 (to FRIENDS OF RAY).
