
The DaVita HealthCare Partners, Inc. Political Action Committee (the "Committee") received a Request for Additional Information ("RFAI") dated July 9, 2014, regarding a \$2,500 contribution to More Conservatives PAC ("MCPAC") that was reported by MCPAC as being received on March 1, 2014, but did not appear in the Committee's relevant filing.

On January 28, 2014, the Committee wrote a check in the amount of \$2,500 to Majority Committee PAC, which is also referred to as "MC PAC." This contribution was disclosed in the Committee's February 2014 monthly filing. However, it appears that due to an inadvertent error, More Conservatives PAC received and deposited the check, rather than Majority Committee PAC. Because Majority Committee PAC was the intended recipient, as was indicated in a letter enclosed with the contribution, the Committee requested a \$2,500 refund from More Conservatives PAC.

To remedy this issue, and correct the public record, the Committee is amending its February 2014 monthly filing to reflect a contribution to More Conservatives PAC on January 28, 2014, in the amount of \$2,500. The Committee received the refund from More Conservatives PAC in the amount of \$2,500 on July 22, 2014, enclosed is a copy of check. This refund will be reported on the August 2014 monthly filing.

This letter is prompted by the Commission's preliminary review of the report referenced above. This notice requests information essential to full public disclosure of your federal election campaign finances. Failure to adequately respond by the response date noted above could result in an audit or enforcement action. Additional information is needed for the following 1 item(s):

- A review of the reports filed by "MORE CONSERVATIVES PAC (MCPAC)" discloses a \$2,500 contribution made by your committee on 3/1/14. However, your reports do not appear to disclose a disbursement to this committee. Further, a miscellaneous electronic submission filed by this committee on 6/26/14 states "Your letter indicates that the Committee reported receiving contributions from three PACs that did not report making a contribution to More Conservatives PAC. MCPAC has reviewed each contribution and verified that each was correctly received, deposited and disclosed on the above referenced report." Please amend your report(s) to disclose this activity or clarify this apparent discrepancy.

Please note, you will not receive an additional notice from the Commission on this matter. Adequate responses must be received by the Commission on or before the due date noted above to be taken into consideration in determining whether audit action will be initiated. Failure to comply with the provisions of the Act may also result in an enforcement action against the committee. Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to taking enforcement action. Requests for extensions of time in which to respond will not be considered.
