Re: Liberty League PAC Amended Form 3X Year-end 2007

I am enclosing herewith an amended Form 3X for year end 2007. This is the first time this report has been amended.

It is being amended for several reasons:


1. I wish to file future reports in electronic format and find it convenient to start off with all transactions in the database. So this report was prepared using FECfile software. This also has the advantage of forcing the transactions to more closely accord with FEC regulations.
2. While the Summary Page has not changed, the Detailed Summary Page has. In particular, the splits in line 11 (a) between itemized and unitemized of the previous report erroneously listed donors of exactly \$200 in the itemized area, and the software version does not.
3. Consequently the Schedule A list is different. See (2) above.
4. The previously filed version omitted page numbers for Schedule A pages. The current filing rectifies this.
5. The total at the foot of the last page in Schedule A was previously omitted and now is present.

6. The creditor listed in Schedule D for the \$1000 liability is now shown as an individual not a firm. The prior reporting was erroneous.
7. In the prior report, Schedule E includes the two debts reported in Schedule D, in error. In the current version they do not appear there, but only in Schedule D.
8. Some cosmetic changes were made in the details lines relating to particular transactions. None of these are substantive changes.

Thanks you for your assistance in helping us file correct reports.




