The Committee is amending its 2007 mid-year report to correct a past computer error that the Committee recently discovered. The Committee's reports are based on a computer program that tallies its receipts and expenditures. The Committee recently discovered that, for several years, the program had been counting some receipts twice and that as a result, the Committee reported a larger amount in unitemized receipts in 2006 and in prior years than were actually received. The Committee has confirmed that the unitemized receipts were accurately reported on its 2007 mid-year report. But, as a result of past errors, the cash on hand reported as of January 1, 2007 was inaccurately stated. The amended report corrects that figure. The Committee has purchased new software which will eliminate this mistake. Please note that the mistake resulted solely from a computer error; that the amounts inaccurately reported were never actually received or deposited by the Committee; that the mistake was confined to unitemized receipts; that all expenditures by the Committee have been reported accurately; that the Committee discovered the error and corrected it on its own initiative, after consulting with its reports analyst, and that the Committee has taken affirmative action to assure that this mistake will not reoccur.
